## **RESOLUTION NO. 13-2022-2023**

## APPROVING AND AUTHORIZING A CONTRACT WITH A-Z BUS SALES, INC. FOR PURCHASE OF ONE SCHOOL BUS TO REPLACE #09-55 PURSUANT TO PUBLIC CONTRACT CODE SECTION 20118

**WHEREAS**, the Tahoe Truckee Unified School District ("District") has an urgent need to obtain new school buses for its students; and

**WHEREAS**, Section 20118 of the Public Contract Code allows the District to enter into a contract to lease or purchase said materials and/or equipment, without advertising for bids, if the District's Governing Board ("Board") determines that it is in the best interest of the District to do so and provided that said materials and/or equipment comply with the specifications and unit prices established by a competitively-bid contract awarded by another local public agency; and

**WHEREAS**, the staff of the District has advised this Board that new school buses meeting the District's needs and requirements were specified in a competitively-bid contract awarded by Waterford Unified School District on November 11, 2021 with a subsequent approval to extend the contract until December 31, 2023, wherein A-Z Bus Sales, Inc. was selected as the low bidder to provide school buses, including a 42-passenger, Blue Bird BBCV 2610 model; and

**WHEREAS**, the staff of the District recommends the Board approve and authorize the District to enter into a contract with A-Z Bus Sales for the purchase of a 42-passenger, Blue Bird BBCV 2610 model school bus at the cost and as described therein.

## NOW, THEREFORE, THE BOARD OF EDUCATION OF THE TAHOE TRUCKEE UNIFIED SCHOOL DISTRICT FINDS, DETERMINES AND RESOLVES as follows:

- 1. The foregoing recitals are true and correct.
- 2. The Purchase Agreement pursuant to Public Contract Code 20118 as described above between TAHOE TRUCKEE UNIFIED SCHOOL DISTRICT and A-Z Bus Sales, Inc. is found to be in the best interest of the District and is hereby approved and ratified.
- 3. The District staff is authorized and directed to take all steps necessary or convenient to one (1) 42-passenger, Blue Bird BBCV 2610 model school bus in accordance with said Agreement.
- 4. The District's Superintendent and her designee are individually authorized and directed to execute the Agreement on behalf of the District (subject to making such changes to the

Agreement as may be necessary or appropriate) to consummate the purchase of school buses, any documents, or supplementary agreements necessary to secure possession, use, or ownership of said school buses, and to approve any amendments as necessary to carry out the provisions of this authorizing Resolution.
